Sporting and Cultural Grant Policy and Criteria

The criteria for the Grant is as follows:

1. You must be an owner or a direct descendant of an owner or a beneficiary of a Whānau Trust which is an owner in Onuku Maori Lands Trust. .
2. You must be selected to:
 - (a) Represent New Zealand overseas and compete in an international tournament or event against other players representing their country and/or
 - (b) Represent overseas – for travel to another country (with a regional or national team or overseas competition and/or
 - (c) Represent at the above levels in your country of residence (i.e. if you are resident in Australia and represent at a Regional or National level in Australia and are required to travel abroad to participate in an international competition.
3. You must provide written confirmation of selection and participation.
4. After the event, you must provide confirmation that you have participated
5. For overseas representation, you must provide travel details and costs you are required to meet.
6. Allocations of grants are entirely at the Trustee's discretion and no reasons will be given for not approving the Grant.
7. Grants are considered on a case by case basis.
